Background Information:

Trustee Smith's resignation created a vacancy on the Board of Trustees for Trustee Area 3. On October 2, 2025, the Board voted to fill the vacancy by making a provisional appointment. The process for making a provisional appointment to the Board is outlined in Education Code Sections 5090-5095 and Board Policies 10221 and 10111.
